Purpose of the Post

To contribute to the work of the department across the range of its activities with a focus on teaching of Cyber/Information Security. In particular the successful candidate will support the development of new teaching material for the Distance Learning MSc in Cyber Security being delivered jointly with the University of London Worldwide using the Coursera platform.

The key objectives and principal accountabilities for this teaching-focussed post are as follows:

- 1. To design, deliver and assess high quality teaching material, including delivery by distance learning.
- 2. To demonstrate and promote a high level of pedagogic and disciplinary scholarship, commensurate with the strategy and reputation of the department and the College.
- 3. To undertake teaching initiatives and other development work for teaching, learning and assessment.
- 4. To play a significant role in departmental, school and college activities, including departmental administrative duties as required.

Key Tasks

To develop, and where necessary help to deliver, high-quality distance learning teaching material in Cyber Security topics, as directed by the Head of Department and the Programme Director. This will include developing practical work assignments using virtual laboratory techniques, as well as working with staff and contract staff supporting delivery to, and assessment of, students.

To develop and deliver high-quality on campus teaching in Information Security topics, as directed by the Head of Department and the Programme Director.

To contribute to departmental administrative tasks, as directed by the Head of Department and the Programme Director.

To engage in scholarly activities to support the work and reputation of the department and institution, including knowledge exchange, external collaboration with both industry and academia, and outreach to society at large.

Other Duties

The duties listed are not exhaustive and may be varied from time to time as dictated by the changing needs of the College. The post holder will be expected to undertake other duties as appropriate and as requested by his/her manager.

The post holder may be required to work at any of the locations at which the business of Royal Holloway is conducted.

Internal and external relationships
