<b>Purpose of the Post</b>	
The purpose of the post is to teach and supervise at undergraduate and postgraduate level, taking full responsibility for the design, management, and delivery of teaching. The postholder will undertake teaching and scholarship in line with their departmental strategy, leading to a growing reputation in their fields of expertise. They will also be required to contribute to the academic administration of the department.	
<b>Key Tasks</b>	
<b>1. Teaching</b> <ul style="list-style-type: none"> <li>• Design and deliver high quality teaching across courses/modules to all levels of undergraduate and postgraduate students (<b>expertise in any of the following modules/areas is essential: Clinical Legal Education, Criminal Law, Contract Law, Equity and Trusts, Land Law, Employment Law, Law of Evidence, Corporate and Commercial Law, Family Law.</b>) through lectures, tutorials, supervisions, practical and seminars, as appropriate. This may include delivery by distance learning or travel between our two campuses.</li> <li>• Design and deliver sound and where appropriate innovative approaches to the learning experience for students with the intention of challenging preconceptions and fostering debate. Develop the ability of students to engage in critical discourse, articulate self-expression, and reasoned argument.</li> <li>• Plan and deliver high quality teaching and feedback using a range of techniques to inspire and engage students.</li> <li>• Identify learning needs of students and define appropriate learning objectives.</li> <li>• Design and develop teaching materials, independently or in collaboration as required.</li> <li>• Supervise the work of students, including field trips / placements where appropriate.</li> <li>• Undertake and complete administrative duties required in the professional delivery of teaching.</li> <li>• Set, mark, and assess work and examinations; select appropriate assessment instruments and criteria; and provide constructive and comprehensive feedback to students.</li> </ul>	

- Undertake Personal Advisor and Academic Tutor duties, and/or provide first-line support for sensitive issues, referring on as appropriate to services providing further assistance.
- Adopt an approachable and accessible attitude towards students, offering office hours, informal advice etc.
- Engage in teaching initiatives, whether internally or externally, and in continuous professional development within and/ or outside the University.
- Develop and engage with professional values linked to respect for diverse learners, widening access, evidence-based approaches, and acknowledgment of the broader context of higher education

## **2. Scholarship**

- Make a positive contribution to scholarship/research groupings and/or centres.
- Develop a high level of contributions to the discipline with outputs appropriate to the subject.
- Maintain an active personal pedagogic research and scholarship plan consistent with the Faculty of Business and Law and University Strategy.
- Make a positive contribution to appropriate research groupings and centres.
- Update knowledge and understanding in area of specialism and transfer this current knowledge into programmes and courses of study.
- Present at conferences and/or exhibit work at other appropriate events.
- Supervise research students in line with disciplinary norms.
- Develop links with external contacts to foster collaboration and generate income.
- Where appropriate to develop and submit funding proposals to appropriate educational funding bodies, working with colleagues where appropriate.
- To undertake and contribute to peer assessment as appropriate.
- To supervise PhD studentships as requested.

## **3. Leadership, Enhancement, External Engagement, and Impact**

- Attend and contribute to departmental, Faculty and University meetings and working groups.
- Participate in undergraduate and postgraduate recruitment, where required.
- Take on roles related to the management of teaching in the department, and/or participate in department, Faculty or University working groups or Committees, as required.
- Engage in departmental activities such as attendance at open days or departmental UCAS and Postgraduate Open Evenings.
- Contribute to the department's strategic planning, and, if required, contribute to university strategic planning processes.
- Advise and provide support to less experienced colleagues.
- Build internal contacts and participate in internal networks for information, scholarship/research purposes and to form relationships for future collaboration.
- Participate in external engagement such as membership of external networks or learned societies and/or professional bodies, undertaking external examining, securing student placements, marketing the institution, facilitating outreach work, generating income, obtaining consultancy projects, or building relationships for future activities.
- To engage and maintain continuous professional development.

## **Other Duties**

The duties listed are not exhaustive and may be varied from time to time as dictated by the changing needs of the University. The post holder will be expected to undertake other duties as appropriate (consistent with the status and grading of the post) and as requested by their line manager.

The post holder may be required to work at any of the locations at which the business of Royal Holloway is conducted.
